<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. Our affiliates include financial companies operating under the: <b>J&amp;D Cash Holdings, LLC; Get Ya Cash names</b>
Nonaffiliates	Companies <b>not related by common ownership</b> or control. They can be financial and nonfinancial companies. Non-affiliates we share with can include <b>lenders; banks; collection agencies; check cashers; tax preparers; brokers; pawnbrokers; rent-to-own, mortgage and insurance companies and retailers.</b>
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Our joint marketing partners include <b>lenders; banks; tax preparers; brokers; pawnbrokers; mortgage companies; and retailers.</b>
